

## General Terms and Conditions (GTC) for using the Internet platform of



The GTC are the basis of the contract between the operators of the internet platform BlueCard-Germany-Bangladesh.com and the registered users. Users can be individuals and legal entities. Operator is the BlueCard-Germany-Bangladesh.com. The general terms and conditions also apply if the operator of BlueCard-Germany-Bangladesh.com will change.

### 1. User

User is who makes an entry in the job-directory, who signs in the database. The user assured that he/she registers/signs in only for himself (application) into the address and data directory on [BlueCard-Germany-Bangladesh.com](http://BlueCard-Germany-Bangladesh.com).

### 2. Object

Object of the contract between the user and the site-operators is the entry in the database, which will be published on the Internet. All, what the user writes in his profile is made accessible to search engines, e.g. google. The user can create, change and manage the display profile within his own access.

### 3. Free offer

The range of the address and job data bank on [BlueCard-Germany-Bangladesh.com](http://BlueCard-Germany-Bangladesh.com) is free to the user until further notice. It is the free decision of the site-operator to offer these services and also at any time without notice, to limit, but also to expand. It is the free decision of the operator to delete an entry of a user. He has not to specify nor inform the user before or after the deletion. Also, the user may at any time request the deletion of his data with a reasonable time period which shall be at least a week. Due to holidays this can be longer.

### 4. Data storage

The user agrees that his personal data will be stored in electronic form by the operator. So, you agree that - as part of the registration and sign in - data and other information you have entered are stored in a database.

With the setting of his data, the user provides the operator the right to publish the information on the site [BlueCard-Germany-Bangladesh.com](http://BlueCard-Germany-Bangladesh.com). The user indemnifies the operator from any claims that are made based on the published content.

### 5. Publication on the Internet

From the user in the address and job directory entered data will be published on the Internet on the domain [BlueCard-Germany-Bangladesh.com](http://BlueCard-Germany-Bangladesh.com). The website with the entered data is not only available for individuals but also for search engines. With this the user expressly agrees. In this context, it is necessary to indicate explicitly that the data entered by the user can be found via a search engine that has taken up the page with the data in its cache, even after the deletion of data on the page [BlueCard-Germany-Bangladesh.com](http://BlueCard-Germany-Bangladesh.com) sometimes over very long period. The operator cannot control this.

To finance its Internet site, the operator does advertising on its website, including on the sites, on which do appear the data entered by the user. As advertising is not directly selected by the operator, it may be possible that an ad of competitors appears on the page. With this, the user expressly agrees.

## **6. Prohibition of Abuse**

The user agrees to not to abuse the offer of this website and not to offend against any laws and any notices, in particular: - not to use defamatory, libelous, obscene, pornographic, racist material and not to distribute any other unlawful material or information; - not to violate any rights of third parties (eg, personality rights, copyrights, patents and trademarks); - not to bring in data that contain viruses, worms, Trojan horses or other similar programs; The user may not share his through registration or access to the account acquired information to third persons. He has to keep the data secret. The operator is entitled but not obliged, to check the contents of uploaded member photos and other image files as well as any text on the [BlueCard-Germany-Bangladesh.com](http://BlueCard-Germany-Bangladesh.com)-platform for compatibility with these terms and the general laws and, if necessary, to delete.

## **7. Liability**

The liability of the operator provides to users is limited in accordance with legal regulations on intent or gross negligence. This also applies to its organs and representatives or agents. The operator assumes no responsibility for the accuracy or content of the user-generated content. Further on, the Operator is not responsible for any misuse of information and the platform. The operator assumes no liability for the availability of the [BlueCard-Germany-Bangladesh.com](http://BlueCard-Germany-Bangladesh.com) system without interruption or failures, disruptions or termination of the offering. The operator assumes no liability for unauthorized acquisition and use of the performed data by third parties. This is especially true for hacker attacks. The User indemnifies the operator from any liability, claims and expenses arising from damages caused by users of the publication of the registered user data. As already mentioned in section 5, the operator assumes no liability that the data are still found and are still visible on search engines after their cancellation on the website [BlueCard-Germany-Bangladesh.com](http://BlueCard-Germany-Bangladesh.com).

## **8. Transmission of data by the user**

The operator does not make any substantive and legal review of the data entry. Responsible for the entire content is solely the user. He assures the accuracy and completeness of submitted data. The user is obliged to check the entry and to correct errors immediately himself.

## **9. Receiving e-mails**

The user agrees that the operator sends to him e-mails, which do inform him both over the Internet platform [BlueCard-Germany-Bangladesh.com](http://BlueCard-Germany-Bangladesh.com) as well as over other projects of the operator. So, the operator can send promotional e-mails to the user.

## **10. Changes of the General Terms and Conditions**

A modification of these General Terms and Conditions may be required by new features, but also by other reasons. The operator shall inform the user of any proposed changes by email to the in the system of the [BlueCard-Germany-Bangladesh.com](mailto:BlueCard-Germany-Bangladesh.com) stored e-mail address of the user. If the user does not explicitly disagree with the planned changes within four weeks from the information, due to his silence by the changes, he /she agrees with the new terms and conditions. In the e-mail to the user the operator will inform the user, that his silence will be interpreted as consent.

## **11. Jurisdiction, Applicable Law**

The jurisdiction is, if allowed, Renningen. The law of the Federal Republic of Germany.

## **12. Severability**

If any provision of these Terms is invalid or incomplete or can be, then the validity of the remaining Terms and Conditions shall not be affected. The ineffective or incomplete provision applies in the case of such a provision as replacing what is the intention and purpose of the invalid or incomplete provision.

## **13. Jurisdiction, Applicable Law**

The court of jurisdiction, if permissible, is Germany, is Renningen. The law of the Federal Republic of Germany is applied.

## **14. Severability**

If any term of these GTC is invalid or incomplete, then the validity of the remaining GTC are unaffected. The invalid or incomplete term in this case is replaced of a regulation what the intention and purpose of the invalid or incomplete term comes closest.
